ORDINANCE 2018-03

AN ORDINANCE OF THE TOWN OF LUTHER, OKLAHOMA AMENDING SECTION 13-303 OF THE TOWN CODE OF THE TOWN OF LUTHER, OKLAHOMA AMENDING THE SECTION NAME AND TEXT BODY TO INCLUDE THE TERM "EMERGENCY MANAGEMENT"; DECLARING REPEALER; AND PROVIDING FOR SEVERABILITY.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF LUTHER OKLAHOMA:

Section 1. That Section 13-303 of the Code of Ordinances for the Town of Luther Oklahoma shall be amended as follows:

13-303: DIRECTOR OF EMERGENCY MANAGEMENT AND CIVIL DEFENSE; POWERS AND DUTIES.

The director of emergency management and civil defense shall be the executive head of the department of emergency management and civil defense and shall be responsible for carrying out the emergency management and civil defense program of the town. He shall serve without compensation but may be reimbursed for expenses incurred in the performance of his duties. It is the duty of the director of emergency management and civil defense, as soon as practicable after his appointment, to perfect an organization to carry out the purposes set forth in this chapter. He shall have all the necessary power and authority to form committees or other bodies and to appoint and designate the chairman or chief officer of such bodies as may be necessary to perfect such an organization. He shall have such further duty and responsibility to cooperate with all emergency management and civil defense agencies of other governmental units including the state and federal government. He shall be an officer of the town and shall have the power necessary to enforce the duties provided in the chapter.

Section 2. REPEALER.

All former ordinances or parts of Ordinances conflicting or inconsistent with the provisions of the Ordinance are hereby repealed.

Section 3. <u>SEVERABILITY.</u>

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, said portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance.

SECTION 4. **EMERGENCY**. It being immediately necessary for the preservation of the public health, peace and safety of the Town of Luther and the inhabitants thereof, an emergency is hereby declared to exist by reason whereof, this Ordinance shall be in full force and effect from and after its passage, as provided by law.
