

RESOLUTION NO. 2021-04R

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF LUTHER, OKLAHOMA, AND MAYORAL PROCLAMATION CALLING FOR A SPECIAL ELECTION IN THE TOWN OF LUTHER ON APRIL 6, 2021, FOR THE PURPOSE OF SUBMITTING TWO QUESTIONS TO THE REGISTERED VOTERS REGARDING: LEVY AND ASSESSMENT OF A SALES TAX OF ONE-HALF OF ONE PERCENT (1/2%) UPON THE GROSS PROCEEDS OR GROSS RECEIPTS DERIVED FROM ALL SALES TAX FOR PURPOSES OF GENERAL MUNICIPAL OPERATIONS, AND LEVY AND ASSESSMENT OF A SALES TAX OF ONE-HALF OF ONE PERCENT (1/2%) UPON THE GROSS PROCEEDS OR GROSS RECEIPTS DERIVED FROM ALL SALES TAX FOR PURPOSES OF CAPITAL IMPROVEMENTS; AND PROVIDING FOR THE CONDUCT OF THE ELECTION BY THE OKLAHOMA COUNTY ELECTION BOARD

WHEREAS, the Board of Trustees of the Town of Luther, Oklahoma, has determined that it is reasonable and proper to seek an increase in sales taxes to support general municipal operations; and

WHEREAS, the Board of Trustees of the Town of Luther, Oklahoma, desires to propose to the voters questions of whether the Town's sales tax levy and assessment should be increased.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LUTHER, OKLAHOMA, THAT the undersigned Mayor of the Town of Luther, Oklahoma, hereby calls a special election for April 6, 2021, for the purpose of submitting to the qualified voters of the Town of Luther, Oklahoma, questions of whether the Town's sales tax assessment and levy should be increased by one percent.

NOW, THEREFORE, BE IT FURTHER RESOLVED THAT the first ballot title of the Election Proposition shall read as follows:

PROPOSITION NO. 1

SHALL ORDINANCE NO. 2021-04, ADOPTED BY THE BOARD OF TRUSTEES OF THE TOWN OF LUTHER, OKLAHOMA, ON THE 28TH DAY OF JANUARY, 2021, WHICH ORDINANCE LEVIES AND ASSESSES A SALES TAX OF ONE-HALF OF ONE PERCENT (1/2%) TO TAKE EFFECT ON JULY 1, 2021, UPON THE GROSS RECEIPTS OR PROCEEDS ON CERTAIN SALES AS HEREIN DEFINED FOR THE PURPOSE OF PROVIDING REVENUES FOR THE SUPPORT OF THE OPERATIONAL FUNCTIONS OF THE MUNICIPAL

GOVERNMENT OF THE TOWN; DEFINING TERMS; PRESCRIBING PROCEDURES, REMEDIES, LIEN AND FIXING PENALTIES AND ESTABLISHING AN EFFECTIVE DATE BE APPROVED?

NOW, THEREFORE, BE IT FURTHER RESOLVED THAT the second ballot title of the Election Proposition shall read as follows:

PROPOSITION NO. 2

SHALL ORDINANCE NO. 2021-03, ADOPTED BY THE BOARD OF TRUSTEES OF THE TOWN OF LUTHER, OKLAHOMA, ON THE 28TH DAY OF JANUARY, 2021, WHICH ORDINANCE LEVIES AND ASSESSES A SALES TAX OF ONE-HALF OF ONE PERCENT (1/2%) TO TAKE EFFECT ON JULY 1, 2021, UPON THE GROSS RECEIPTS OR PROCEEDS ON CERTAIN SALES AS HEREIN DEFINED FOR THE PURPOSE OF PROVIDING REVENUES FOR CAPITAL IMPROVEMENTS OF THE TOWN; DEFINING TERMS; PRESCRIBING PROCEDURES, REMEDIES, LIEN AND FIXING PENALTIES AND ESTABLISHING AN EFFECTIVE DATE BE APPROVED?

NOW, THEREFORE, BE IT FURTHER RESOLVED THAT the election shall be conducted by the Oklahoma County Election Board.


NOW, THEREFORE, BE IT FURTHER RESOLVED THAT the precinct officials, polling places, hours, and rules for said election shall be determined by the Oklahoma County Election Board in the same manner as determined by State and County elections.

NOW, THEREFORE, BE IT FURTHER RESOLVED THAT absentee ballots will be allowed in the election.

NOW, THEREFORE, BE IT FURTHER RESOLVED THAT only registered voters of the

Town of Luther, Oklahoma, may vote upon the proposition as above set forth and that said proposition must be approved by a majority of the said voters voting on the proposition (50%, plus one vote).


