A RESOLUTION OF THE LUTHER PUBLIC WORKS AUTHORITY, AUTHORIZING AN APPLICATION FOR A RURAL ECONOMIC ACTION PLAN (REAP) GRANT FROM THE OKLAHOMA WATER RESOURCES BOARD (OWRB)

WHEREAS, the following circumstances have made it justifiable to apply for grant funds from the Oklahoma Water Resources Board: (1) replacement of a four inch (4") sanitary sewer service line is necessary to service the individuals connected to it presently, and (2) replacement and potential upgrade of the four inch (4") sanitary sewer line is necessary to expand capacity for the Town and further to provide sanitary sewer service to a new housing development and commercial area; and

WHEREAS, the Luther Public Works Authority is financially incapable of remedying the situation which threatens the public health and welfare of the people of the Town of Luther; and

WHEREAS, it is in the best interest of the citizens of the Town of Luther for the Luther Public Works Authority to expedite the preparation and submission of an application for financial assistance to the Oklahoma Water Resources Board in the form of a grant.

NOW THEREFORE, BE IT RESOLVED that a need is hereby recognized and declared to exist in the Town of Luther, and by reason thereof, William Terry Arps, Chairman of the Luther Public Works Authority, is hereby authorized and directed to sign an application and related documents necessary to file and process a grant application with the Oklahoma Water Resources Board on behalf of the Luther Public Works Authority.
