5. Approval of March 7, 2022, minutes. **Anna Campbell made a motion to approve the minutes as presented, 2nd by Jason Roach. The Vote: All (5) Yes.**

6. **PUBLIC HEARING** to consider and take appropriate action, including a recommendation to the Board of Trustees to approve or deny an amendment to Chapter 4, "Offenses Against the Health, Welfare and Morals," of the Code of Ordinances of the Town of Luther, Oklahoma, and specifically amending Section 10-424, "Location of Stores Selling Tobacco and Vapor Products". **Jason Roach made a motion to recommend approval of Item 6 to the Town Board of Trustees, 2nd by David Threatt.
